MINUTES of meeting held on November 28th 2016 had been circulated and were agreed with one amendment. Adlington to be added to list of clubs who required an invoice.

MATTERS ARISING:

1 CriHQ We were still awaiting the transfer of information from I team mate

- Could clubs please give Tracey Brooks the name of their person who was to be responsible for CriHQ. If further information was needed then Mike Cregan, Phil Andrews, Tracey Brooks and Mike Buckley could be contacted.
- There had been no more feedback from Ian Pilkington in regards to I pads etc...
- Admin training would go ahead at the end of January

2 Indoor withdrawals. No team had given back word and therefore were committed to the competition. It was now too late to pull out without a penalty.

3 Cricket ball orders. These were needed by the 18th December. If not ordered by then then an order would be made for 24 tiflex balls and 12 pink balls for the T20. If clubs second teams were to use the tiflex balls then they would need to order more. The old reader balls could be used for second team games only and as a spare in the Stafford trophy matches.

4 Additional Clubs. Still on going. It was felt we definitely needed 2 divisions of 12. We awaited the outcome of the LCB AGM s LCB were monitoring expansions of leagues

5 T20. Members were asked to vote on 4 groups of 5 or 5 groups of 4. The latter won so that clubs would play each other twice.

PETER STAFFORD TROPHY. It was minuted in the October meeting that this is run on the LKO rules but members had agreed in the November meeting to run as ordinary league matches which would give people practice in using CricHQ. It was agreed that this minute be amended.

Rules stood as follows.

1 matches will be played to league rules.

2 points, including bonus points will be awarded as per league rules.

3. The four group winners with the most points will host the quarterfinals with priority given to first teams. Their opponents will be the fifth winner with the least points and the three runners up with the most points.

4 If points are tied Rule 23c will apply. This applies across the groups.

5 For the quarter final and semi if necessary, first and second teams will be paired.

6 In group matches premier first teams will two home matches, Association teams one. This will be reversed in 2018.

7 Matches will not be replayed. In the KO stages the tie will be decided by a bowl out or toss of a coin.

FINANCE. There were still some outstanding bills to pay in regards to the junior and senior presentation venues and trophies. Invoices for the extra £200 asked for were available. In future clubs who wanted itemised invoices will be able to have them at 3 monthly intervals.
